1. The nature and purpose of the Terms and Conditions and the Study Guide (hereinafter referred to as the “Prospectus”)

Information on the training and examination of road drivers and road transport professionals laying down detailed rules for the application of 24/2005. (IV. 21.) GKM (hereinafter referred to as “the GKM Decree”) is defined in the 2. Annex and is considered as the General Terms and Conditions (GTC).

The purpose of the Prospectus is to reach an agreement between the training body and the participants in the subject matter, establishing a uniform set of conditions and establishing conditions for cooperation between them.

These terms and conditions are part of the contract between the parties, and only the parties are entitled to deviate from them in written declaration containing the same will of the parties.

2. The material, personal and territorial scope of the Prospectus

The Prospectus material scope is expanded of the training activities provided by the training organization (road drivers training courses). The Prospectus is within the personal scope of the training: training body, participant.

The territorial scope of the Prospectus covers all administrative units in the territory of Hungary where is engaged in training activities.

3. Temporal scope of the Prospectus, amendment

This Prospectus shall be effective from the commencement date of the training and shall remain valid until revoked, including any interim amendments.

The Driving School is entitled to amend the content of this Prospectus. Amendments shall enter into force on the date of their publication.

The current version of the Prospectus shall be continuously made available on the Driving School’s official website and at the customer service office.

The participant is entitled to request information on the currently effective content of the Prospectus at any time and is obliged to familiarize themselves with and comply with its provisions throughout the duration of the training.

With regard to fees and charges, the always currently effective fee schedule shall apply, in accordance with the relevant provisions of this Prospectus.

Amendments to the Prospectus shall not affect services already paid for and duly credited to the participant.

6. How to apply for the course and its conditions

6.1. In order to apply, the participant may contact the Driving School as follows:

- Directly visit the Driving School office
- by phone
- by email or
- by filling out the form on the Site, "Apply Now!"

Participants may apply for the Driving School's training courses in person or online, after reviewing this Prospectus and the Driving School's Privacy Policy, by completing and signing an application form. For the participant have the opportunity to send the application form in advance by e-mail to the Driving School. However, the original of the application form is still required to give personally at the Driving School office.

6.2. PAV examination is not required.

6.3. Conditions for admission to the course:

- has reached the age of 16 years and 6 months;
- payment of the first part of the course fee,
- a duly completed and signed application form.
- Hungarian residence permits valid at least for 6 months or Hungarian address card.

6.4. Deadline for Commencing the Course

- Following enrollment at the Driving School, the student is required to complete registration and start the course within 90 calendar days from the receipt of the registration link sent by the e-Titán system via email.
- If the student fails to complete the registration and start the course within the above deadline, the course registration opportunity shall automatically expire, and the course cannot be started using the previously issued registration link.
- The student acknowledges that in such case the Driving School has fulfilled its obligation by providing access and the possibility of registration; therefore, no refund, credit, or offset of paid fees shall be available.
- To continue the training, the student must initiate a new course registration and pay the associated fees again.
- The access period provided for the learning material shall only be applicable after the registration has been finalized and the course has been started.

7. Conditions for passing the exam:

7.1. Conditions for passing the theoretical exam:

- completed 16 years and 9 months of age;
- completion of the theoretical course,
- less than 9 months elapsed since the beginning of the theoretical course,
- payment of theoretical examination fee,
- a duly completed and signed application form,
- write and read knowledge
- a declaration of primary education and
- a valid medical fitness certificate.

Within 9 months of the registration, the student must pass the theoretical exam, which in case of unsuccessful can retry, but within 12 months of the registration must pass a successful theoretical exam. After these deadlines, the student can only take the theoretical exam again after repeating the course. The application for the theoretical exam must be submitted at least 20 working days before the deadline to ensure the Driving School can secure an exam date in time.

The successful traffic knowledge exam is valid for 2 years. If the examinee does not complete all exams successfully within this period, all their successful exams and completed courses will become invalid.

In connection with organizing examinations, the Driving School may charge an exam administration fee, which covers internal costs related to exam administration, scheduling coordination, and related administrative services.

7.2. Prerequisites for Practical Examination:

- completed 17 years of age,
- completion of the required hours (29 practical + 1 exam hours) and the prescribed driving distance (580 km),
- a properly completed and signed application form and
- payment of the practical exam fee.

7.3. Conditions for Issue of Examination Certificate:

- proof of successful theoretical exam,
- proof of successful practice exam
- successful First Aid Exam Certification is First Aid Knowledge issued by the Hungarian Red Cross subjects. Exemption may be requested under the appropriate medical education certificate pursuant to Decree 31/1992 (XII.19.) NM.
- Proof of primary education, which is possible in the following ways:
 - enter your identity documents with your doctoral title
 - the origin of the document certifying school completion, or a notary or certified by the issuer copy of. In the case of foreign certificates and diplomas, the original document and its certified translation, unless if the diploma or certificate can be found in “Certificate and Diploma Sample” is established by the Transport Authority.
 - in the case of foreign certificates and diplomas, by a competent Hungarian authority recognition certificate, localization clause, official certificate, official verification, information or a student relationship issued by a higher education institution in Hungary not older than 3 months a certificate stating that the certificate or diploma in question certifies at least a level of basic education presupposes its existence.

8. Course subjects and required number of hours and compulsory driving distance

8.1. Theoretical subjects and lessons

- Basic transport knowledge: 18 hours
- Driving theory: 6 hours
- Structural and operational knowledge: 4 hours

The theoretical lessons last 45 minutes / lesson. Theoretical education is 4 x 45 minutes, ie 4 lessons. In the case of e-learning, theoretical education is based on the curriculum of EduKresz.

8.2. Practical sessions, hours, distance

- Mandatory distance: 580 km
- Required number of hours: 29 hours + 1 exam lesson consisting of:
 - Basic education: 9 hours
 - Main training (Traffic): 20 hours - as follows:
 - City: 14 hours
 - Highway: 4 hours
 - Night: 2 hours
 - Exam: 1 hour

Practical training can be started after a successful theoretical exam. The date of practical lessons can be agreed with a vocational trainer.

Practical lessons last 50 minutes. In Basic education max. 2 hours driving is possible per day, in Main education maximum. 2 × 2 hours per day, among min. 2 hours break.

When reaching 580 km drive and completing 29+1 hours of practical training as well as in case of unsuccessful traffic exam, the instructor may propose additional practical classes.

The duration of the traffic exam is 60 minutes, of which 50 minutes are continuous driving. The specified period includes information of the examiners from the progress of the examination and the assessment of the exam.

After the fifth unsuccessful traffic exam, PAV examination is mandatory.

8.3. Accelerated Practical Training

- The Driving School offers the possibility of accelerated practical training. The purpose of accelerated training is to provide driving sessions more frequently than usual.
- The student acknowledges that the planned frequency of 4–5 driving sessions per week does not constitute a guaranteed commitment and is merely an objective, which may vary depending on instructor availability, exam scheduling, and the student's own availability.
- The use of accelerated practical training requires flexible scheduling on the part of the student and adaptation to the time slots offered by the instructor.
- The student acknowledges that choosing accelerated practical training does not give rise to any claim for compensation, penalty, fee reduction, or other claims against the Driving School if the above scheduling objective cannot be met during a given period.

9. Absenteeism

9.1. The trainer's delay, absence

In practical training, the students need min. 20 minutes to wait for the instructor, a missed driving lesson must be replaced later without paying an additional hourly fee.

9.2. Lack of student

If a student is prevented from attending, he / she can cancel the agreed practical training lesson as follows:

- at least 48 hours before the beginning of the lesson - without any obligation to pay,
- within 48 hours before the beginning of the lesson, must pay the hourly fee for the lesson

- If the learner does not appear in the agreed session without prior notification, this is the case paying the hourly fee for the unused hour and replace the missed practical driving lesson.

11. Amount of fees, payment methods and payment deadlines

The amount of fees, payment methods, and payment deadlines can be found in "Terms and Conditions and Student Guide for Category B Driving Course Students "Appendix A" Tuition Fees, Payment Methods, and Payment Deadlines" Prospectus.

12. Conditions for exempting from listening and examination individual subjects

The Driving School determines the conditions of the discharge in accordance with the GKM Regulation as follows:

12.1. Exemption from listening to subjects

In all cases, the head of the Driving School decides on the exemption of subjects.

- The head of the Driving School will accept certain subjects from the courses before starting the training the student who is already qualified for the subject.

The specific qualifications and degrees that exempt students from attending certain theoretical subjects and obtaining first aid knowledge are determined by the Transport Authority. The list of such qualifications can be found in point 4 of Appendix 3 of the GKM Regulation.

12.2. Exemption from examination obligation

Initiating an Exemption from Examination - by the Head of School certified - by attaching a photocopy of the deed to the application form. Obligation to take the exam, the exemption is granted by the Transport Authority upon request

13. The method of transfer of the student and the issuance of the certificate of the completed education, consequences of the student's transfer

At the student's request, the head of the school is obliged to issue a certificate of completed education, the so-called "Training Certificate", and deliver it to the student either in paper or electronic form within 3 business days. The fee for paid but unused hours will be refunded in cash by the Driving School at the same time as the issuance of the certificate.

17. Rights and obligations of the candidate

- The Driving School informs the candidate of the place and date of the exam.
- At the time and place of the exam, the candidate must be seated in a dress appropriate to the driving must be present.
- The identity of the candidate must be verified with a valid identity card, address card or other valid document (passport) for personal identification.
- The official exam results is included in the examination protocol, which the candidate will acknowledge by signing it.
- In case of non-participation on the exam, or late or unsuccessful exam, new exam only if you pay for a repeat exam, unless the candidate declares his / her absence in person or in writing to the Inspectorate at the latest on the 6th day prior to the exam day or confirms with medical certificate within 8 days of cessation of the disease to the Inspectorate.
- The candidate must report the change in his / her personal data within 8 days.
- If the doctor prescribes restrictions (glasses or contact lenses), the learner is obliged to do so carry practical glasses or contact lenses with you during practice and exams. If the exam cannot be maintained due to the lack of glasses or contact lenses, material liability is the candidate.
- If the candidate already holds a valid driving license or exam certificate, the exams it is required to present it to the examiner at this occasion.

18. Major regulatory requirements for issuing a driving license

After successful exams (theory and practical), the candidate must appear at the competent Hungarian government office responsible for issuing driving licences (Okmányiroda / Government Document Office).

The Okmányiroda prepares the driving license document. Then the following documents will be presented:

- identity card;
- a card certifying the successful completion of a first-aid course;
- address card or Hungarian resident permit valid for at least 6 months;
- medical certificate.

In the case of non-Hungarian citizens, a 6-month residence permit, or permanent registered address is required.

Driving licenses for category B are valid only for domestically until the driver reaches the age of 18 years.

A driving license is issued for a period of 2 years from the date of first acquisition of driving license qualifies as a novice driving license.

19. Mixed Provisions

The provisions of this section shall apply to all parts of this Prospectus and to the appendices related thereto. In matters not regulated by this Prospectus, the provisions of the applicable Hungarian legislation shall govern.

The student acknowledges that the Driving School is entitled to unilaterally modify its fee schedule. Tuition fees, practical training fees, and the consideration for any other services provided by the Driving School shall in all cases be determined according to the fee schedule in effect at the time the service is ordered, becomes due, or is performed, regardless of the conditions or fees applicable at the time the student applied for the training.

The student accepts that any price change shall apply to services not yet paid for and or not yet performed, and therefore the student shall not be entitled to raise any objection, complaint, or claim against the Driving School on any legal basis in connection with such price changes.

Fees for practical driving lessons already paid for and demonstrably credited to the student shall not be modified retroactively.

Prices listed in the appendices to this Prospectus are provided for informational purposes only. The actually applicable fees shall in all cases be determined according to the fee schedule applied by the Driving School and in force at the time the service is ordered or performed.

The Driving School provides the student with a copy of this Prospectus at the time of application for the course and, for the purpose of proper information of applicants, makes it available in a clearly visible place at the customer service premises, and publishes and continuously updates it on the Website.

Tuition Fees, Payment Methods, and Payment Deadlines

1. Tuition Fees for English Courses

1.1. Fees for general enrollment:

- e-Titán category “B” e-learning course in English (180 days, 75 hours): 109,990 HUF
 - E-learning extension fee 29,990 HUF
- e-Titán first aid e-learning (Available only in Hungarian)
 - When registering, alongside the "B" category e-learning course: 20,000 HUF.
 - Without package discount: 30,000 HUF
- Practical driving lesson fee: 12,990 HUF / 1 x 50-minute lesson
- Accelerated practical driving lesson fee: 16,990 HUF / 50-minute lesson

1.1.1. Fees for Extra Lessons (after completing the mandatory 29+1 hours)

- Extra driving lesson fee: 12,990 HUF / 1 x 50-minute extra driving lesson
- Accelerated extra driving lesson fee: 16,990 HUF / 50-minute lesson

For each practical driving lesson (including both mandatory and extra lessons), an additional surcharge of 3,000 HUF per 50-minute lesson applies for sessions before 8:00, after 17:00, and on weekends.

1.2. The fee for students transferring from another institution with a training certificate:

- The administrative fee for transferring, payable on the day of enrollment: 30,000 HUF
- Practical driving lesson fee: 12,990 HUF / 1 x 50-minute lesson
- Accelerated practical driving lesson fee: 16,990 HUF / 50-minute lesson

1.2.1. Fees for Extra Lessons (after completing the mandatory 29+1 hours)

- Extra driving lesson fee: 12,990 HUF / 1 x 50-minute extra driving lesson
- Accelerated extra driving lesson fee: 16,990 HUF / 50-minute lesson

For each practical driving lesson (including both mandatory and extra lessons), an additional surcharge of 3,000 HUF per 50-minute lesson applies for sessions before 8:00, after 17:00, and on weekends.

1.3. Practical driving for license holders:

- Practical driving lesson fee: 12,990 HUF / 1 x 50-minute lesson

Practical driving is only available in packages of 10 hours.

For driving lessons, an additional surcharge of 3,000 HUF per 50-minute lesson applies for sessions before 8:00, after 17:00, and on weekends.

1.4. Fee for the conversion of foreign driving licenses:

- Administration fee without e-learning course: 80,000 HUF
- Administration fee with e-Titán "B" category e-learning course in English: 109,990 HUF
- Practical driving lesson fee: 12,990 HUF / 1 x 50-minute lesson
- Accelerated practical driving lesson fee: 16,990 HUF / 50-minute lesson

Driving lessons can only be taken in packages of 10 hours.

For each practical driving lesson (including both mandatory and extra lessons), an additional surcharge of 3,000 HUF per 50-minute lesson applies for sessions before 8:00, after 17:00, and on weekends.

3. Payment Deadlines

- Theoretical course:
 - The fee for the theoretical course is payable upon enrollment.
- First aid e-learning education:
 - When included in the package, payment is due upon enrollment.
 - It may also be requested separately at any time, in which case a separate fee applies.
- Practical training (uniformly in all cases):
 - Payment of practical training fees shall be made in accordance with the payment schedule determined by the Driving School.
 - In the case of installment payment, the payment deadlines shall be governed by Section 3.1.

- If installment payment is not selected, the fee for the mandatory 29+1 practical lessons (580 km) must be paid no later than at the start of the first practical driving lesson.
- The fee for any additional lessons shall be paid at the beginning of each lesson, including any make-up lessons.

3.1. Installment Payment

Installment payment is available and may be requested by the student at the time of enrollment. The terms and conditions of installment payment shall be agreed between the student and the Driving School during registration, taking into account the selected training type and the current fee schedule.

4. Examination fees, payment methods, and deadlines

4.1. Examination fees

The examination fees listed in this Appendix, including first aid examination fees and medical fitness examination fees, are provided for informational purposes only. Examination fees are subject to official authority tariffs or the pricing policies of the relevant service providers and may therefore change.

The actual payable fee shall always be the amount in effect at the time of applying for the given examination.

- KRESZ theory exam fee: 4,600 HUF
- KRESZ theory retake fee: 4,600 HUF + 5,000 HUF administration fee, total: 9,600 HUF
- Practical driving exam fee: 11,000 HUF + 5,000 HUF administration fee, total: 16,000 HUF
- First aid course fee: approx. 20,000 HUF
- First aid exam fee: approx. 20,000 HUF
- Medical fitness certificate fee: 7,200 HUF

4.2. Exam administration fee

HUF 5,000 per occasion, applicable to any KRESZ theory retake exam and all practical driving exams, including both first attempts and retakes.

This fee covers internal administrative costs related to exam scheduling, coordination, and documentation.

4.3. Payment methods and deadlines for examination fees

- Theory exam fee:
 - Must be paid together with the theoretical course upon registration.
 - Retake exam fees must be paid before applying for the exam.
 - The payment method follows the instructions in section 2 (Tuition payment methods).
- Practical exam fee:
 - Must be paid before applying for the practical exam.
 - The payment method follows the instructions in section 2 (Tuition payment methods).
- First aid exam fee:
 - Must be paid to the organizing institution before applying for the first aid exam.
- Medical Fitness Examination:
 - Must be obtained before applying for the theoretical exam.
 - The examination fee must be paid to the doctor performing the examination.
